With regard to canoeing in general, and paddling at Rietvlei dam, and in consideration for the permission granted to members of the Centurion Canoe Club ("CCC") to run within the Rietvlei Reserve ("the Reserve") but outside the premises leased by the Pretoria Sailing Club

I, the undersigned, do hereby state and agree that:

1. Agree and undertake to run only on the specifically demarcated routes, as indicated on the map which is available from CCC. I confirm that I am aware of the route and have familiarized myself with the boundaries thereof.
2. Undertake to comply with all instructions and directions given by any committee member of CCC, regarding running in the Reserve and the route to be followed.
3. **Confirm that I am aware of the potential dangers of running in the Reserve and accept all risks in connection therewith, and sole responsibility for such damages.**
4. **I am aware that hippos and crocodiles do occur in Rietvlei dam and accept all risks in connection therewith, and sole responsibility for such damages.**
5. I am aware of the potential dangers involved to which I will be exposed by participating in canoeing and associated activities;
6. I am further aware that Canoeing South Africa and its affiliated Unions, and all subordinate bodies and officials as well as sponsors of events, in organising and permitting my participation in such activities and in establishing and enforcing safety measures in regards thereto, cannot ensure my safety and/or the adequacy of such measures.
7. As such, I undertake to:
 - a) participate in all canoeing and associated activities at my own sole risk and responsibility;
 - b) exonerate all persons and bodies involved in the organisation and sponsorship of canoeing under the auspices of Canoeing South Africa and affiliated Unions from, and indemnify them against, any loss or damage which I or any others, including my dependents, may suffer as a result of any injury or death resulting from any act or omission on the part of such body or person, whether due to negligence (including gross negligence) or otherwise;
 - c) comply with all safety and other rules and regulations of Canoeing South Africa and all affiliated Unions and subordinate bodies;

Indemnify, exonerate and hold harmless the City of Tshwane Metropolitan Municipality, the Department of Nature Conservation, the Department of Water Affairs and Forestry, the Pretoria Sailing Club, CCC, any of their members, employees or office bearers or any other person whatsoever, against any loss or damage which I, or any others, including my heirs or dependents, may suffer, directly or indirectly, as a result of any injury or death arising out of or in connection with running in the Reserve or from any act or omission on the part of any such body or person, howsoever arising, and whether same be due to negligence (including gross negligence) or otherwise.
9. **I have read and understand the rules according to Canoeing South Africa, City of Tshwane Metropolitan Municipality, the Department of Nature Conservation, the Department of Water Affairs and Forestry, the Pretoria Sailing Club, CCC., and undertake to obey these rules at all times.**
10. **I will advise the club secretary of any changes in contact information during the year.**
